



The History, the Facts, and the Statistics You Need to Know From the Groundbreaking Film

History of Abuse

The vaccination programs in the United States and across the globe have a long history of causing, ignoring, and concealing vaccine injuries. Both the injuries and the coverup continue today despite the suffering of victims and those who speak out on their behalf.

This global coverup is unsurprising given that nearly 20% of the World Health Organization (W.H.O.) budget comes from just one man: [Bill Gates](#). Through the Bill and Melinda Gates [Foundation](#) and their partner, [Gavi, the Vaccine Alliance](#), Bill Gates controls the W.H.O. and directs their missions through his nearly \$1 billion in annual [donations](#). This money allows Bill Gates to [dictate](#) government vaccine policies and terms of vaccine compliance throughout Africa.

A few of the historic atrocities covered in the film include:

The Tuskegee Study

The Tuskegee syphilis study that went [on for 40 years](#) provides clear evidence that the government and other agencies were using African-American men as guinea pigs and was conducted without the patients' consent. Furthermore, [40 of the participants' wives contracted the disease and 19 children were born with congenital syphilis](#) leaving a legacy that none of the families could forget.

MMR Vaccines

A Centers for Disease Control and Prevention (CDC) [study](#) discovered that African-American boys who receive the MMR vaccine "on-time" by the age of 3 are [3.36 times more likely to be diagnosed with severe autism](#) as Black boys who waited until they were older. [This exponential increase](#) was not seen in white children.

After its discovery, the CDC, America's largest health department, [destroyed the evidence of the relationship between the timing of the MMR and autism](#). The public only came to know about their actions after a senior CDC vaccine safety scientist was granted federal [whistleblower](#) protection by the Obama administration.



Passed in 2015, California Senate Bill 277 ([SB277](#)) makes the MMR vaccine a requirement to obtain a pre-school through grade 12 education unless an exemption is provided by a medical doctor, which is all but impossible to obtain. The new law forces African-American parents to either vaccinate their vulnerable children or educate them at home.

SB277 doesn't take into consideration that African Americans have much higher antibody responses when given the vaccine for rubella virus as compared to any other race in the population. A study by [Dr. Gregory Poland](#) of the Mayo Clinic showed that African-American children need [only half the dose](#) in order for the rubella vaccine to be effective. This means that African-American children are being "over-dosed" with today's current vaccine concentration.

Diphtheria-tetanus-pertussis (DTP)

The whole-cell versions of DTP vaccines were removed from the US and European childhood schedules in the mid-1990s because of their [exceedingly high propensity to harm recipients](#). In 2001, the US began phasing out the use of [mercury preservative](#) in routine childhood vaccines after [public backlash and parental advocacy on behalf of brain injured children](#) reached a boiling point. However, Bill Gates and the W.H.O. [continue](#) to give these vaccines to [116 million African children](#) every year. Their use continues even after the 2017 Danish government

discovery that girls who got the DTP vaccines are 10 times more likely to die than unvaccinated girls. These highly reactive and mercury-containing vaccines are still being given in Africa today.

Measles

Measles mortality began drastically declining in the 1930s and had already decreased by 90% before the vaccine was introduced 1963. Even though medical establishments credit measles vaccines for saving lives, the lower measles mortality is due to advances in preventing and treating dehydration and improvements in living conditions the US experienced in the early 20th century including less crowded living conditions, better nutrition, and improved sanitation systems.

Beginning in 1989, the CDC conducted an experiment on nearly 1,500 Black and Hispanic infants in Los Angeles, using an unlicensed measles vaccine, without obtaining permission from the parents or disclosing that the drug was a high potency experimental vaccine. The CDC only halted its secret experiment in 1991 when companion clinical trials conducted on illiterate populations in Senegal, Guinea-Bissau, and Haiti showed increased death rates and severe immune system disorders among female infants who received the vaccine. Other Notable Vaccine Injury Atrocities:

- ◆ In 2014, the W.H.O. gave 1 million Kenyan women of childbearing age a tetanus vaccine that contained anti-fertility hormones, unbeknownst to recipients. Instead of investigating, health officials punished those who reported it. Catholic doctors and bishops raised alarms.
- ◆ At least 50 Chadian children were paralyzed after receiving Bill Gates' funded meningitis vaccine.

And It's Still Happening Today with COVID-19

There are signs that history is repeating itself with the coronavirus (SARS-CoV-2, the cause of COVID-19 disease) which was declared a pandemic in 2020.

- ◆ Black people are dying from COVID-19 at **2.4x at the rate of white people and 23% of the COVID-19 deaths are Black people**, according to the COVID Tracking Project. According to the Vaccine Adverse Event Reporting System (VAERS), in the eight weeks since vaccination began, (between Dec. 14, 2020 and Feb. 18, 2021), **19,907 reports of COVID-19 vaccine adverse events** have been reported, including 1,095 deaths and 3,767 serious injuries.
- ◆ People who are deficient in vitamin D are more susceptible to contracting the virus. As melanin blocks vitamin D absorption, African Americans are incredibly vulnerable with 38.5% of African Americans deficient in vitamin D. However, there is very little information that encourages African Americans to take vitamin D supplements to fight off COVID-19.
- ◆ There are also discussions that the COVID-19 vaccination could become mandatory before people are allowed to return to school, work, or travel, leaving many with very little choice but to submit to receiving it.

It's time to acknowledge that public health, the pharmaceutical industry, and the medical system have never concerned themselves with the true health of Black people in America and across the globe—and circumstances in 2021 are no different. The practice of treating Black communities as laboratories for testing blockbuster drugs and vaccines must come to a halt immediately.
